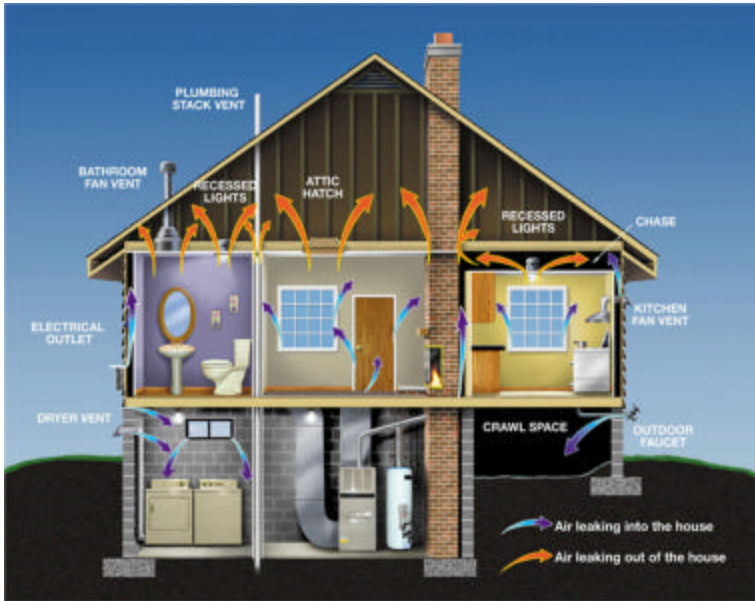


You Could Qualify for CSI's **FREE Weatherization** Program

Why should I have my home weatherized? *Weatherization saves money.*

By reducing energy use in households, utility costs are reduced. It makes homes warmer in the winter and cooler in the summer. It also has the added benefit of creating safer, healthier, and more comfortable places to live.

What kind of residences can be weatherized? *Houses, apartments,*

duplexes, and mobile homes that are rented or owned can all qualify. Landlords must give permission for services and agree to pay a small fee. Some landlords have this fee waived if the situation warrants. CSI can assist applicants in contacting their landlords.

So, who qualifies? As with most programs, certain income guidelines must be met.

To encourage weatherization as a solution to high utility costs, the program's participation guidelines are more generous than most. For example, a single person can have a yearly income of \$21,780 and a family of four (4) can make \$44,700.

1	\$21,780
2	\$29,420
3	\$37,060
4	\$44,700
5	\$52,340
6	\$59,980
7	\$67,620
8	\$75,260
<i>Add \$7,640 for each additional individual</i>	

DID YOU KNOW?
